Late Collection Fee - Parents arriving 10 minutes late to collect children will be charged £25.

Nursery Education Funding is only intended to cover the cost to deliver 15 or 30 hours a week of high-quality flexible childcare. It is not intended to cover the cost of snacks, consumables, and enrichment programmes. All funded hours will incur a charge of 50p per hour to cover this. Those parents receiving some additional forms of government support and entitled to funding for their children from 2 years may be entitled to a reduction in this charge, please speak to us about this. Working parents may be eligible the term after their child is 9 months old to 15 hours of Nursery Education Funding for 38 weeks of the year. This must be applied for at Childcare Choices **www.childcarechoices.gov.uk**

All parents will be eligible for 15 hours (Universal Funding) of Nursery Education Funding for 38 weeks of the year the term after their child is 3 years old.

At Cornmeadow Early Years & Families we allow funded hours, to be used for all sessions booked except to extend the day from 8am for Breakfast and till 6pm for Afternoon Tea.

Parents will be required to, complete a parent Nursery Education Funding Parent Declaration claim form for each setting their child attends and, designate the hours to be claimed by each setting.

In some circumstances additional charges may be incurred for excursions, but this will only take place after parent consultation.

Parents will find information on the Governments Tax Free Childcare at **www.childcarechoices.gov.uk**. For every £8 parents pay into their online account, the government will add an extra £2, up to £2,000 per child per year. The money can then be used to cover all invoices at the nursery.

Funded hours unused during term time can be used against hours booked in Holiday Club - see below

Holiday Club Charges - Parents book as required

Holiday Club is only available to children that are registered with Cornmeadow Early Years & Families. (Easter – 2 weeks, Summer – 5 weeks. Hot lunches are not available at Holiday Club, Parents will need to provide a packed lunch.)
